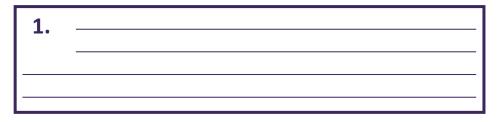

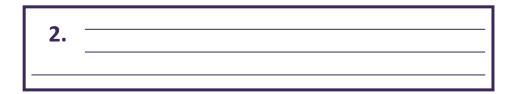


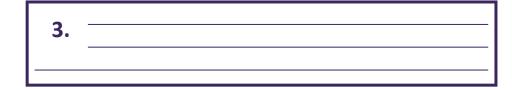


### Overview of an Audit Report: Part 1

#### **Independent audit report**







First or 'opinion' paragraph/ section

Provides unqualified audit opinion

- True or fair view (IFRS) and/or Fairly presented (IFRS and US)
- Clean opinion

Also provides qualified opinion, giving limitations or exceptions to accounting standards and explanatory paragraphs regarding exceptions

Second or 'basis of opinion' paragraph/ section Describes the basis for providing the opinion Accounting Standards under which the Audit was conducted Confirmation of independence and ethical standards of auditors 'Going concern' conclusions

Third or 'scope' paragraph/ section

Details the nature of the audit process

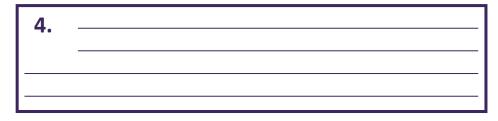


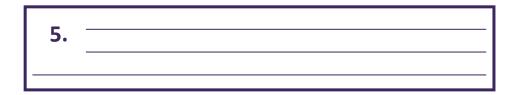


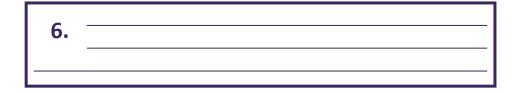


### Overview of an Audit Report: Part 2

#### Independent audit report







Fourth or 'Key Audit Matters' paragraph/ section

Highlight for the users/ reader of the report

- The existence of significant events that should be disclosed
- Any areas that involved significant judgment
- Emphasis of Matter

#### Fifth paragraph/ section

Describes the materiality thresholds for the usability of the financial statements

Directors responsibilities towards the financial statements

Auditors' responsibilities towards the audit

#### Sixth paragraph/ section

Any other reporting responsibility (legal and/or regulatory)





#### **Definition:**

Key Audit Matters (KAM) are based on topics which are discussed with those (on the company's side) responsible for governance. The auditor then assesses these matters and identifies which ones require significant attention during the audit

#### **Identification Criteria required by the auditor to consider:**

- Areas that are deemed to be susceptible to higher risks of material misstatements.
- Any area that requires significant auditor's judgement.
- The effect on the audit of significant events or transactions that have taken place during the period.





An EOM paragraph aims to highlight to the users a crucial matter that has already been disclosed in the financial statements, which the auditor deems essential for their comprehension.

you know that note in the financial statements, the one about the uncertainty surrounding the legal dispute? We, the auditors, think it's really important, so make sure you read it!





#### Emphasis of Matter – Example of Boeing 737 MAX Grounding

Liabilities related to the 737 MAX Grounding – Refer to Notes 13 and 21 to the financial statements

#### Critical Audit Matter Description

In 2019, following two fatal 737 MAX accidents, the Federal Aviation Administration (FAA) and non-U.S. civil aviation authorities issued orders suspending commercial operations of 737 MAX aircraft (the "737 MAX Grounding"). Deliveries resumed in the U.S. in late 2020 following rescission by the FAA of its grounding order. The 737 MAX remains grounded in certain non-U.S. jurisdictions. In addition, multiple legal actions have been filed against the Company following the fatal accidents and various governmental and regulatory investigations and inquiries continue relating to the accidents and the 737 MAX aircraft.

During 2019, the Company recorded an initial liability in connection with estimated payments, concessions and other in-kind consideration it intends to provide to customers for disruptions related to the 737 MAX Grounding and associated delivery delays. This liability totaled \$5.5 billion at December 31, 2020 and is reflected in the financial statements in Accrued liabilities. This represents the Company's best estimate of future concessions and other consideration to its customers, and is necessarily based on individual negotiations with customers and the substance of such negotiations.

Significant judgment is involved in management's ability to assess and reasonably estimate potential additional financial statement effects or a range of loss, if any, resulting from the outcome of 737 MAX-related litigation and the results of the various ongoing governmental and regulatory investigations and inquiries related to the 737 MAX.

The subjectivity of the liability associated with providing consideration to customers resulting from the 737 MAX Grounding and the complexity of assessing the outcome of the ongoing litigation and investigations related to the 737 MAX required a high degree of auditor judgment and increased audit effort.





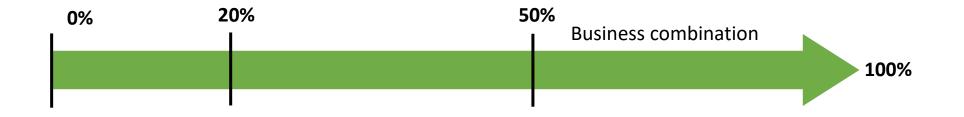
## What are the Auditors trying to tell you?

- 1. During 2019, Boeing recorded a liability of \$5.5 billion related to estimated payments, concessions, and other consideration that it intends to provide to customers for disruptions caused by the Grounding and associated delivery delays.
- 2. This liability, which reflects Boeing's best estimate of future concessions and consideration to customers, is based on <u>individual negotiations with customers</u> and <u>the substance of such negotiations</u>.
- 3. However, <u>the liability is subjective</u>, and the complexity of assessing the outcome of the ongoing litigation and investigations <u>requires a high degree of auditor judgment and increased audit effort</u>.

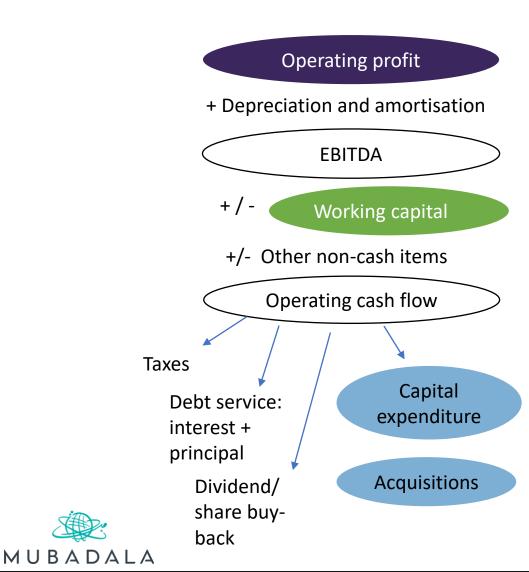






EMERGING MARKE





- Margin pressures: Lower prices/higher marketing costs to retain or gain market share
- Inability to transfer increasing raw material/energy costs
- Increase of trade receivable days to support revenue

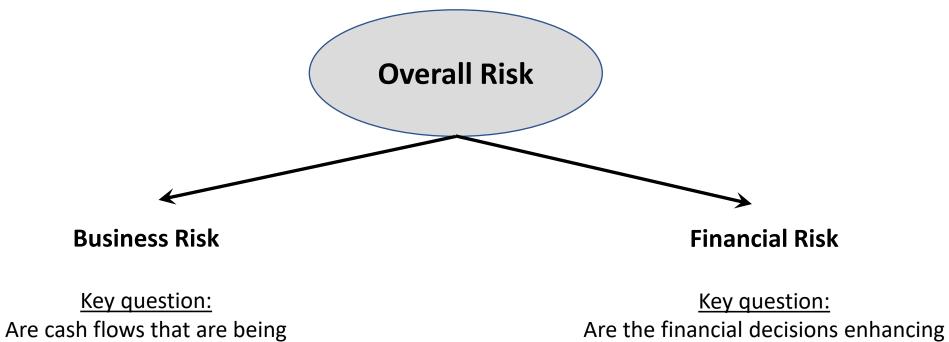

#### **Key Consideration: The level and appropriateness of Debt**

#### Question: How much debt can be serviced given the projected cash?

- Having forecasted the financials for ABC Ltd, you assess that they are likely to generate an annual adjusted cash flow of AED 18.7 mln (operating cash flow less other business expenses related to taxes, dividends and capex) over the next 5 years.
- Based on these projections, you would like to assess the maximum debt that the company should be taking on assuming:
  - Scenario 1: There are no covenants from the banking group
  - Scenario 2: The banking group insists on a minimum coverage ratio of 1.2x
- The company's cost of debt is assumed to be unchanged at 6%, and its tax rate at 30%





#### Cash flow available to service debt (existing and new debt)

Cash available to service debt

**Discount rate:** After tax cost of borrowing reflecting new capital structure

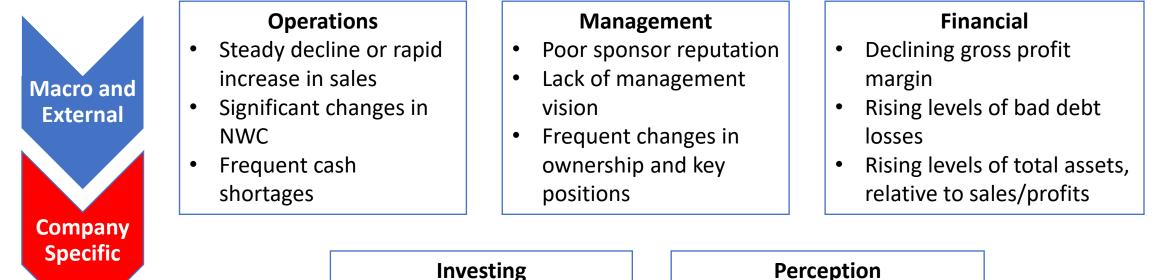

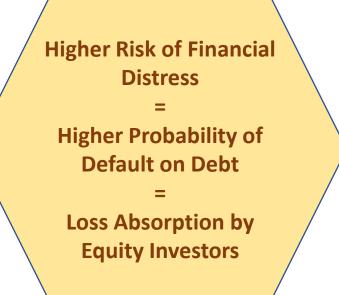

### Estimating Debt Default Risk

#### There are a variety of methodologies that help us evaluate default risk:

- Rating agency ratings Moody's, S&P, etc
- Quantitative calculators e.g. Moody's analytics (KMV), Altman Z-Scores
- Asset swap, credit and credit default spreads (CDS)
- Fundamental Credit Analysis





### Altman Z-Score

- Scoring model to 'predict' probability of default (or bankruptcy)
- Scoring range of 1 to 4
- A low (Z) score (< 1.8) suggests a higher likelihood of default
- A high (Z) score (> 3) suggests credit safey
- Formulaic approach using a combination of:
  - Financial ratios
  - A weight assigned to each financial ratio

Z-Score = 1.2(R1) + 1.4(R2) + 3.3(R3) + 0.6(R4) + 1(R5)

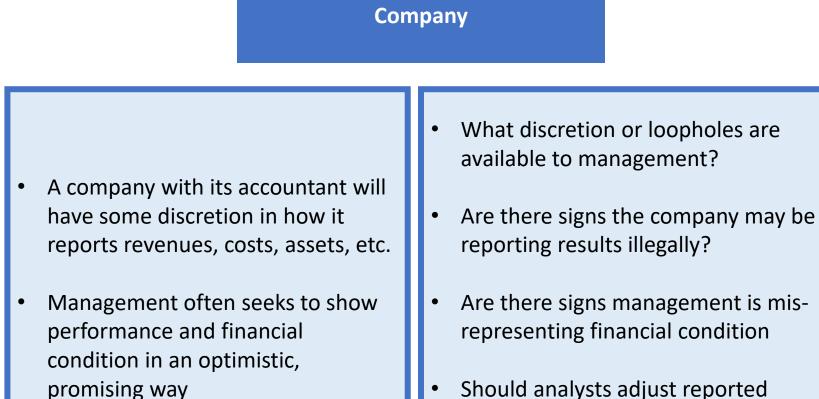
R1 = Working Capital/Total AssetsR2 = Retained Earnings/Total AssetsR3 = EBIT/Total Assets

R4 = MV of Equity/Total Liabilities R5 = Total Sales/Total Assets

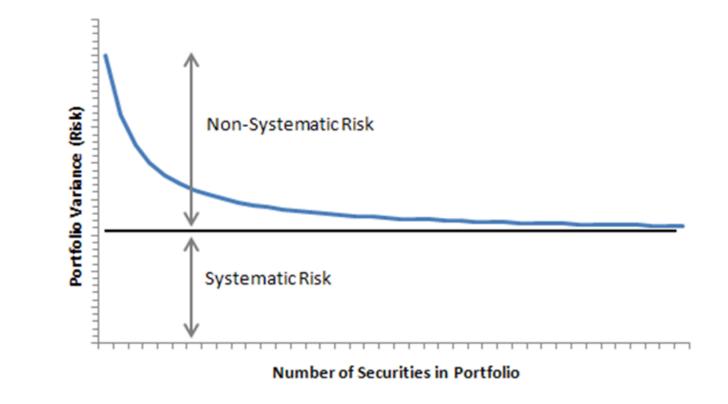


- Premature or fictitious revenue recognition
- Premature recognition of **suppliers discount**
- Creativity down the profit & loss statement (non-operating income)
- Inappropriate use of provisions
- Increase of cash and/or profit through sale of assets: Invoice discounting; sale and lease back
- Asset revaluation (downwards) plus subsequent profit on disposal
- Capitalized expenses (that other companies treat as operating expenses) or accelerated revenue (or suppliers discounts)
- **Deferring costs** (further than is reasonable, delay in reporting accrued expenses)
- Extended depreciation (further than expected life of the asset)

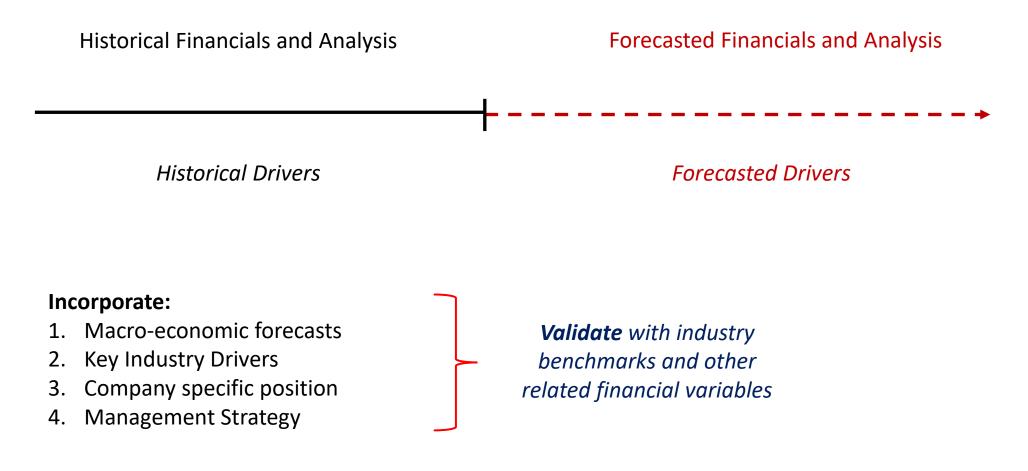

Sales Revenues	<ul> <li>Division and geographic break-up, price vs volume, industry specific metrics (sales/sq feet)</li> <li>Consider industry factors, input prices, constraints, order books, etc</li> </ul>
Operating Profit	<ul> <li>Division and geographic break-up, opex/ sales and leverage, input price trends</li> <li>Consider industry factors, cost and pricing strategy, competition, business mix, etc</li> </ul>
Net Working Capital	<ul> <li>NWC/Sales, Days Ratios</li> <li>Consider historical efficiency, sales drivers, changes in industry environment, etc</li> </ul>
Capex and Depreciation	<ul> <li>Capex/Sales, Sales Turnover Ratios, Maintenance costs, Equipment costs, Useful life</li> <li>Consider historical trends, management strategy, capacity utilization, industry dynamics, etc</li> </ul>

# **Normalising Earnings**







#### Key Question:

- Have we cleaned the data to remove items that may not be 'representative'?
- Do we have a clear estimate of the 'recurring' earnings of the business?





**Recurring net income** is bottom line net profit adjusted for the post-tax impact of non-recurring items only

This is then used to calculate normalised earnings per share measures which are used in valuation

As for EBIT and EBITDA, there is subjectivity in deciding which items are non-recurring

All non-recurring items adjusted in EBIT and EBITDA are also non-recurring for net income





Net incomeXAdd back: post-tax non-recurring expensesXDeduct: post-tax non-recurring income(X)Recurring net incomeX

- Companies sometimes disclose the tax impact of non-recurring items
- If the tax impact has not been disclosed then use the companies marginal tax rate to estimate the tax effect of non-recurring items, if taxable

*Post-tax non-recurring item = Pre-tax non recurring item \* (1-MTR)*

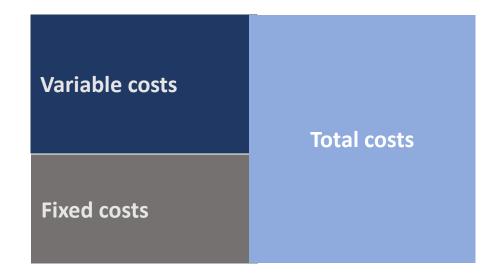




### Related Concept: Operating Leverage

#### Examining fixed vs. variable costs (FC/TC, VC/TC)

- Understand the advantages of low fixed costs when sales decline
- Understand the advantages of low variable costs when sales increase







#### • Breakeven sales

• The level of sales required for a business to cover its fixed costs and make neither a profit nor a loss:

Fixed costs Gross margin(decimal)

• To estimate fixed costs, assume these are:

Gross profit - Profit before tax

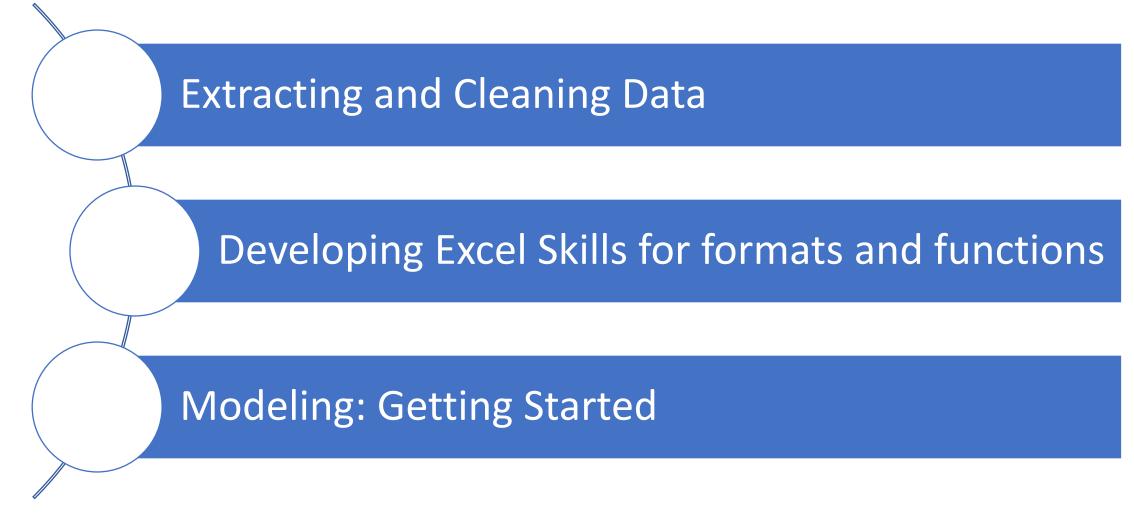
- Margin of safety
  - The gap between current sales and breakeven sales
  - Expressed absolutely or as a percentage

Sales - Breakeven Sales

- Is the company able to pass cost increases to customers (variable costs)?
- Does the company have leverage in reducing costs when sales decline?
- Is lack of demand reducing pricing and margins?











#### Our objective is to:

- 1. Extract the financial data efficiently
- 2. Input the data into the relevant worksheet (historical financials)
- 3. Normalize the historical earnings





# **Modeling Considerations**





### **Objective of the Model**

• Valuation? Debt Repayment? Project Evaluation?

#### **Inputs and Outputs**

- Primary and Secondary (Derived) Inputs
- Required Output Data and Visuals

#### **User-friendliness**

- How easy is it to find information?
- How easy is it to understand the "logic"?
- How flexible is your model? A model is not an answer key, it is a tool. It should allow for changes in scenarios





- A set of financial statements I/S, B/S, and CFS including relevant details
  - Historical data
  - Forecast period
- To build the values for the forecast period, we need a set of Assumptions – one assumption for each line in the financial statements
- Ratios, summary tables, for analysis
- Cover worksheet





### Data Legends

- Models consists of historical data and your forecasts
- It is standard to distinguish between them visually to make it easy for a user to identify
- Example legend:

text / ### in black are calculation or forecast
text / ### in blue are historical or hard-coded

use "A" or "Actual" for past dates use "P", "F" or "Projected" or "Forecasted" for future dates

text / ### in a yellow box are assumptions





Try to use only the visible field of a worksheet

Try to group logical inputs and outputs together

Try to keep your formulas simple to understand

Expenses can be shown as negative or positive – just be consistent

Cash flows should always be shown as positive if cash-generative and negative if cashusage





#### **Everything on one worksheet**

- Benefit is do not need to move from worksheet to worksheet
- Suitable for simple models
- Ensure the model is built in logical progression, running from top to bottom or from left to right
- If it's a larger model, may want to use "group" to collapse and expand sections (make sure your user knows how to use this functionality)

#### **One function one worksheet**

- Benefit of keeping the model structure clear even if does requiring moving from 1 worksheet to another
- Keeps workings within field of vision on each worksheet
- Suitable for normal to large models
- Ensure the worksheets are appropriately named so your user knows where to find information
- Ensure your cover page provides a table of contents





### Building a Simple Model

#### Building a model is iterative but in general the steps are as follows:

- Step 1: build the I/S first (this is because certain I/S items feed into the B/S)
   Some I/S items may be dependent on B/S, link to the B/S item's cell address(es) anyway, it will update as the B/S is built
- **Step 2:** build the B/S footnote calculations before building the B/S do not build cash!
- Step 3: build the CFS next the ending balance feeds into the "cash" item on the BS
- **Step 4:** do you balance?
- Step 5: complete ratios & summary remember this is the output and for now sanity checks your model

This is a starting point. A fuller set of model building guidelines shall follow

### Tips: When you do not balance

- Delete all values but year 1 before checking
- "Ctrl + ~" shows worksheet as formulas
  - Step 1: check that you deducted expenses if you showed them as positive values
  - Step 2: make sure you do not total something twice
  - Step 3: make sure you calculated changes in assets, liabilities & equities correctly (& capex is cashnegative)
- In general:
  - Make sure you picked up the correct assumption
    - Use "ctrl + [" to find first input note this only works if first input is from assumptions
  - Check that forecast values are consistent with historic values
    - No dramatic switching from gain to loss, from positive to negative value, or vice versa
    - No dramatic rates of change that cannot be explained
  - It is possible to have more than 1 error





### More on Errors!

- Is it possible to balance but still have mistakes in your model? Yes!
- Harder to find such errors
- Tips:
- Check for extreme changes, check margins & ratios
- Change assumptions and see if your model still balances and makes sense!





### Exercise

#### Let us change the assumptions:

- Change the debt repayment schedule
- Debt repayment of USD 1000 per annum

What happened? Does it make sense?





#### **Modeling solution:**

#### Add a revolving line of credit in the model

- In your model, you need to have the flexibility that when there is cash, it is recorded in cash, but when there is no or negative cash, there is a more sensible record
- Insert a "CP-RCF" item in current liabilities
  - If ending cash is positive, the value goes to cash (assets); if cash is negative, the value goes to CP-RCF (liabilities)

#### **Forecasting solution:**

## Need a realistic debt issuance/repayment schedule in your forecast

- Commercial paper (CP) and or its back-stop, a revolving line of credit (RCF), are typically used by companies to daily cash flow short fall, in particular do to seasonal variations, OWC management, and unexpected needs in cash
- Companies should also have a strategy for medium- and long- term funding – and your model should reflect that





To accommodate the possibility of overdraft, the B/S needs a "CP-RCF" line (included in total liabilities)

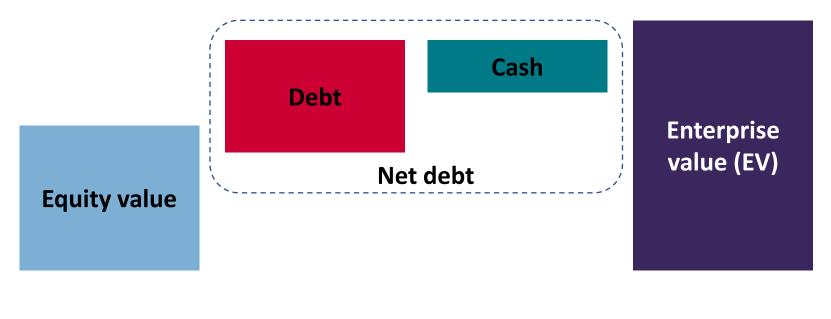


## What are we valuing?

- Usually, we value a firm. A firm is a group of assets (and associated liabilities) used to generate profit for its owners:
  - Equal to the value of the financing to support operations (at its simplest, debt, cash and/or equity)
- Valuation can be done at equity or enterprise level:

Equity value reflects only the claims due to equity holders

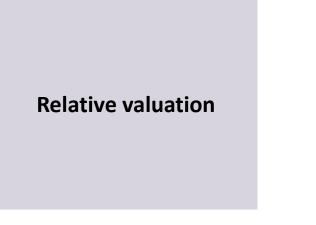
Enterprise value reflects the value of claims by all stakeholders







### Valuation Methodologies



Absolute valuation



References what other people think about the value of the asset we are looking at

- Using multiples
- Comparable company analysis (using public companies)
- Comparable transaction analysis (M&A based comps)

Based on assumptions of future performance of the company

- DCF PV of future operating cash flows available to stakeholders
- Implied private equity valuation range based on target returns given a certain capital structure and exit timeframe





#### **Equity Valuation**

Equity value = PV of cash available for distribution to equity holders

- Free Cash Flow To Equity (FCFE)
- Discounted at required return of equity

Only used to value financial institutions (no ability to distinguish operational and financial assets)

#### **Enterprise Value**

Enterprise value = PV of cash flows from operations available for distribution to all capital providers

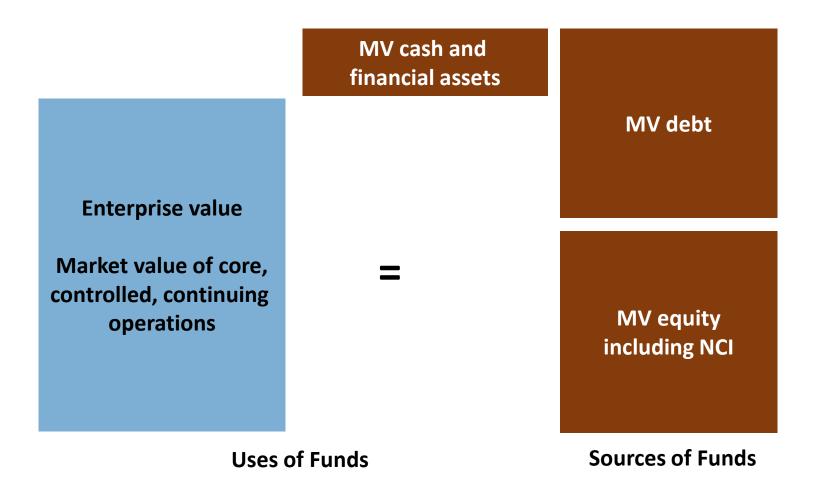
- Free Cash Flow To Firm (FCFF)
- Discounted at weighted average required return of all capital providers (WACC)

Will need to bridge from Enterprise/ Firm Value to Equity value





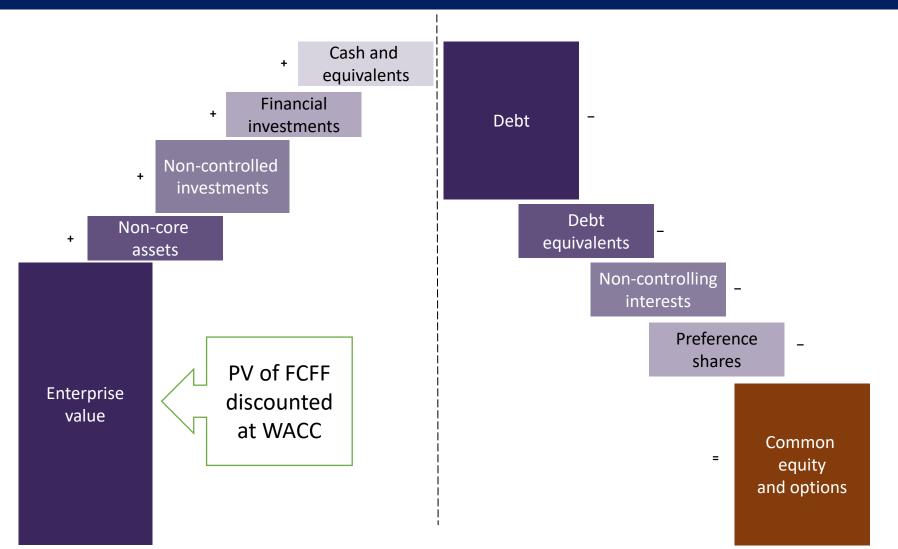
Enterprise value = MV equity + MV debt - MV financial assets

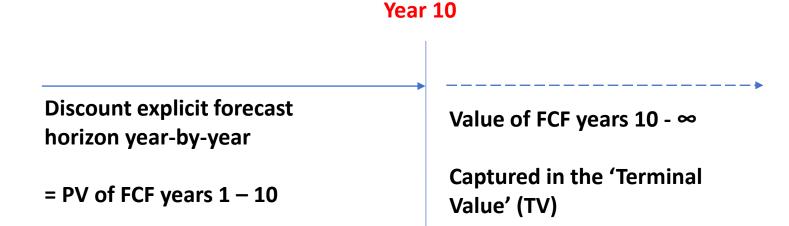
- **Do not** adjust FCF for non-cash **stock-based compensation**
- Forecast of **operating items only** is required:
  - Excludes any income from financial assets
  - Excludes claims of financing capital providers





#### **FCF Forecast**

- Good DCF will be based on valid, justifiable forecasting assumptions
- Forecast horizon may be 5 to 10 years
- Need to forecast until reach sustainable mid-cycle position, viz, 'Steady state'







### **Terminal Value Methods**

#### **Growing perpetuity**

- Assumes constant long-term growth rate (LTG) in FCF in perpetuity.
- Ensure integrity of final forecast FCF.
- Should reflect steady state

$$TV_N = \frac{Steady \ state \ FCF_N \ x \ (1 + LTG)}{(WACC - LTG)}$$

- Requires discounting back from final year (N)
- May ignore link between reinvestment and growth

#### **EV multiple**

- Use a multiple of final forecast EBIT(DA).
- Ensure integrity of final year forecast.
- The multiple must reflect steady state growth and margins
- Use a mature multiple

 $TV_N$  = Steady state EBIT(DA)<sub>N</sub> x Multiple

• Requires discounting back from final year (N)





#### **Discount rate = Hurdle rate**

#### Value is only created if the FCF at least covers the cost of funding.

- FCFF are discounted by WACC:
  - WACC must be calculated using a capital structure which is appropriate to the length of your forecast period:
    - The 'long-term'/'target'/'targeted'/'optimal' capital structure. This may be different from the company's actual capital structure
    - Beta must also be calculated according to the target capital structure (expressed as D/E)
  - Use up-to-date market values
- Note: FCFE are discounted by 'Cost of Equity'





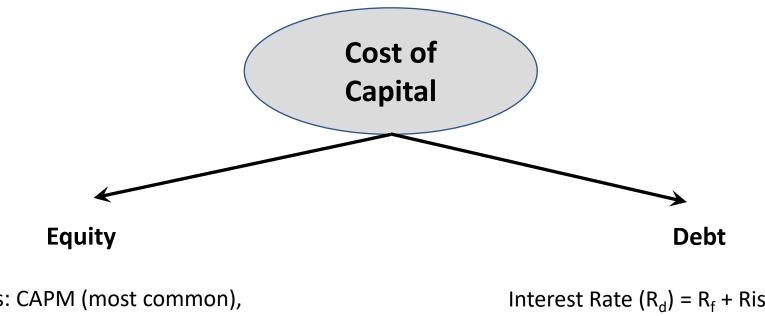
D

- WACC = <u>(Kd x D) + (Ke x E)</u> (D + E)
- WACC = Weighted average cost of capital (aka cost of capital). Weighted individual cost of each capital structure component
  - Influenced by perceptions of risk and opportunity cost
  - Driven by market expectations
- $K_d$  = Cost of debt after tax = Rd x (1 t)
  - = Market value of target debt amount
- K<sub>e</sub> = Cost of equity
- E = Market value of target equity amount





#### Cost of Debt and Equity: Overview



Methods: CAPM (most common), Dividend Discount, Build-up method

CAPM:  $K_e = R_f + \beta (R_{market} - R_f)$ 



Beta: estimator of stock's return vs equity market return

Interest Rate  $(R_d) = R_f + Risk Premium$ 

Risk Premium: comparables, credit ratings, fundamental analysis

 $K_d = R_d * (1 - tax rate)$
