### Financial Advice

### Budgeting

- Manage money helps to pay bills and save.
- First step: Create a budget
- Track incomes/expenses.
- Helps to set savings goals &create an emergency reserve
- Then as savings grow, develop an investment plan or pay into pension.

### Borrowing

- Keep it under control.
- Assess whether its worth it
- Good debt should leave them better off (long term).
- Bad debts drain wealth, offer no real prospect for future.
- Interest rate and APR?
- Repayments?
- Penalties?
- Cost per week/month?

### **Investment and Saving**

- Regular savings add up, gain interest.
- Compounding increases saving's worth.
- Wide choice of saving accounts in the UK
- Investment involves committing money into investment vehicles.
- Higher risks than savings but outperform them in the long run.



### Financial Advice

#### Later-Life Planning

- High life expectancy = higher level of income to enjoy retirement.
- Relying on the state is not advisable as demographics are changing & cost of state pension is increasing.
- Later the client starts saving for retirement, the lesser they will be able to put in the retirement fund.

#### **Estate Planning**

- Consider appropriate steps to ensure wealth passes smoothly to beneficiaries and in a tax-efficient way.
- Assess the client's assets and liabilities.
- Use balance sheet for key areas:
  - POA to protect their interests
  - Whom they wish to inherit their estate to
  - Extent of any liability to IHT and whether any action can be take to mitigate.

### **Tax Planning**


- Tax Avoidance vs Tax evasion
- No longer differentiated as legal and illegal.
- Public perceptions leading to the terms beings more carefully defined.
- 'Tax mitigation' is now referred as acceptable tax planning.
- International cooperation is increasingly used

#### Offshore Consideration

- Each country has its own rules for tax.
- Worldwide or territorialbased system of taxation.
- Worldwide System: residents taxed on their worldwide income and gains.
- Territorial-based System: residents taxed only on income & gains arising in that country.



## Legal Concepts in Financial Advice



### The Financial Advice Process

Determine the client's requirements

Formulate a strategy to meet client's objectives

Implement by selecting suitable products

Revisit recommended investments to ensure needs are being met

Revisit the objectives and revise the strategy & products needed

### The Financial Advice Process

### Client Relationship & Communication Skills

- Establish an effective relationship with the client
- Nature of relationship depends on service given
- Adviser has a fiduciary duty to observe highest standards
- Best advisers listen to what the client wants

### Attitude to Risk

- Client's risk profile to be based on risk tolerance, attitude to risk and capacity for loss
- Risk profile: huge impact on financial planning
- Assess income and wealth relative to liabilities

### Matching Solutions with Needs

- Personal details
- Financial details
- Objectives
- Risk tolerance
- Liquidity and Time Horizons
- Tax Status
- Investment Preferences

### Suitability & Affordability

- Assess whether services are suitable for professional or retail client.
- Any other investment service should ensure its appropriate for that particular client.
- No personal recommendations should be made unless it suits the client

### The Financial Advice Process

### Information given to Clients

- Give info about their firm and any proposed investment
- Disclose material information
- Charges, cancellation rights, early encashment
- Penalties, risk warnings and any special or nonstandard terms

### **Consumer Rights**

- Rights of a consumer are dictated by the contract between client and firm
- Clearly outline areas surrounding unfair terms, consumer credit, right to change of mind, 'cooling-off period' and how to withdraw or terminate

### Monitor & Review the Clients' Circumstances

- Imperative for client to review their plans and monitor progress towards objectives.
- Regularly update as minor changes lead to significant impact on financials
- Agree with client beforehand when periodic assessments and reviews will be done.
